3 **Resolution honoring Carl Saucedo on the occasion of his retirement as a Court**
4 **Reporter.**

6 WHEREAS, Carl Saucedo has worked as a court reporter for 30 years, the last 20 of
7 which he has worked for the City and County of San Francisco; and

8 WHEREAS, Mr. Saucedo was born in Houston, Texas, where he went to segregated
9 schools; and,

10 WHEREAS, He wanted to be a doctor but there were not such opportunities available
11 in Texas, and;

12 WHEREAS, Mr. Saucedo moved to the Bay Area because it was a more integrated
13 place with greater opportunities, and;

14 WHEREAS, He trained as an X-Ray technician but could not get a job because they
15 were not hiring African-Americans, and;

16 WHEREAS, Mr. Saucedo joined the United States Air Force, during which service he
17 traveled to Japan and met two life-long friends, and;

18 WHEREAS, Upon returning to the Bay Area, he decided to go to Court Reporting
19 School, and;

20 WHEREAS, Mr. Saucedo met his future wife Marge, who is from a very well-
21 established Berkeley African-American family, an accomplished pianist who for many years
22 ran a music school and taught piano, and currently does computer work for non-profit groups,
23 and;

1 WHEREAS, Mr. Saucedo first worked as a court reporter in San Mateo County, then
2 Alameda County, and for the past 20 years in San Francisco, the last 10 years of which he
3 worked with Judge Ellen Chaitin, and;

4 WHEREAS, Mr. Saucedo is the past President of the San Francisco Court Reporters
5 Association, past President of the California Court Reporters Association, and past President
6 of the National Court Reporters Association; now, therefore, be it

7 RESOLVED, That the Board of Supervisors of San Francisco commends and
8 congratulates Carl Saucedo on the occasion of his retirement and wishes him well in his
9 future endeavors.




