3 **Resolution authorizing the Department of Human Services to accept and expend a two-**
4 **year grant in the amount of \$95,000 from the CalWORKs/Child Welfare Partnership**
5 **Project for improving coordination between the department's Child Welfare and**
6 **Welfare-To-Work programs.**

8 WHEREAS, The Department of Human Services intends to use the funds to improve
9 the capacity of its child welfare programs to identify and respond to issues of poverty among
10 the families it serves, and for its welfare-to-work program to better respond to issues of family
11 and child well-being; and,

12 WHEREAS, The Department of Human Services has made substantial progress in
13 coordinating existing cases that are shared between its welfare-to-work and child welfare
14 programs, but still needs to improve the two programs' ability to prevent child maltreatment by
15 providing early support to families experiencing economic duress; and,

16 WHEREAS, The Department of Human Services will use grant funds to develop
17 assessment instruments, protocols, training, and communication mechanisms that will better
18 integrate its welfare-to-work and child welfare services; and,

19 WHEREAS, The Department proposes to maximize use of available grant funds on
20 program expenditures by not including indirect costs in the grant budget; now, therefore, be it


21 **RESOLVED**, That the Board of Supervisors hereby waives inclusion of indirect costs in
22 the grant budget; and be it

23 **FURTHER RESOLVED**, That the Department was awarded these funds through a
24 competitive grant process of the CalWORKs/Child Welfare Partnership Project, which is

1 funded by the Stuart Foundation and launched in partnership with the California Department
2 of Social Services; and be it

3 FURTHER RESOLVED, That the grant funds must be expended over a two-year
4 period.


