6 WHEREAS, Robert J. Lull, M.D., Chief of Nuclear Medicine at San Francisco General  
7 Hospital and Director of the Resident Training Program, served as the 134<sup>th</sup> President of the  
8 San Francisco Medical Society in 2002; and,

9 WHEREAS, The San Francisco Medical Society is a non-profit organization consisting  
10 of over 1,200 physicians, residents, and medical students that advance the interests of San  
11 Francisco physicians and their patients in the interest of public health; and,

12 WHEREAS, Dr. Lull is a member of the California Medical Association and a lifetime  
13 member of the American Medical Association; and,

14 WHEREAS, Dr. Lull is the only physician member of the Southwestern Low Level  
15 Radioactive Waste Compact Commission, where he represents the state of California; and,

16 WHEREAS, Dr. Lull is the first full-time San Francisco General Hospital staff physician  
17 to be elected President of the San Francisco Medical Society in its 134-year history; and,

18 WHEREAS, Dr. Lull is deeply involved in the community on behalf of organized  
19 medicine and has worked hard to bring local issues to state and national awareness; and,

20 WHEREAS, Dr. Lull has continually lobbied on behalf of his peers in San Francisco  
21 and Sacramento in an effort to bring physicians, patients, and the public together surrounding  
22 important health care issues; now, therefore, be it


