3 **Resolution enacting and rescinding traffic regulations on various streets.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the movement of
7 vehicles are hereby enacted or rescinded as designated below:

8 **BICYCLE LANES - ESTABLISH**

9
10 Golden Gate Avenue, westbound from Masonic to Parker Avenues; and

11 Golden Gate Avenue, eastbound from Masonic Avenue to 130 feet westerly.

12 **MULTIPLE LEFT TURN LANES - ESTABLISH**

13 10th Street, southbound at Brannan Street, Division Street, and Potrero Avenue
14 (mandatory left turn for curb lane, shared left turn/through for 2nd lane from
curb). Curb lane is currently designated as a left turn lane.

15 **STREET CLOSURE - ESTABLISH**

16 Tiffany Avenue, northbound direction only, at Duncan Street

17 **CROSSWALK CLOSURE - ESTABLISH**

18 Duncan Street, at Tiffany Avenue, west crosswalk (crossing Duncan Street)

19 **NO LEFT TURN - ESTABLISH**

20 Duncan Street, westbound, at Tiffany Avenue (prohibits access from Valencia Street to
21 southbound Tiffany Avenue)

22 **RIGHT TURN ONLY - ESTABLISH**

23 Duncan Street, eastbound, at Tiffany Avenue (prohibits access from Duncan Street to
24 Valencia Street)

10th Street, southbound at Brannan Street, Division Street, and Potrero Avenue (mandatory left turn for curb lane, shared left turn/through for 2nd lane from curb). Curb lane is currently designated as a left turn lane.

STREET CLOSURE - ESTABLISH

Tiffany Avenue, northbound direction only, at Duncan Street

CROSSWALK CLOSURE - ESTABLISH

Duncan Street, at Tiffany Avenue, west crosswalk (crossing Duncan Street)

NO LEFT TURN - ESTABLISH

Duncan Street, westbound, at Tiffany Avenue (prohibits access from Valencia Street to southbound Tiffany Avenue)

RIGHT TURN ONLY - ESTABLISH

Duncan Street, eastbound, at Tiffany Avenue (prohibits access from Duncan Street to Valencia Street)


