13 transfer of a Type 21 off-sale general alcoholic beverage control license for the purpose
14 of upgrading its current Type 20 off-sale beer and wine alcoholic beverage control
15 license for Maruwa Foods Company of America located at 1737 Post Street; and,

16 WHEREAS, The City Planning Department has verified that the area is properly
17 zoned; and,

18 WHEREAS, The Police Department recommends that the liquor license
19 application be approved with conditions; now, therefore, be it

20 RESOLVED, That in accordance with Section 23958.4 of the California Business
21 and Professions Code, the Board of Supervisors of the City and County of San
22 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
23 off-sale general alcoholic beverage control license for the purpose of upgrading its
24 current Type 20 off-sale beer and wine alcoholic beverage control license from 22
25 Peace Plaza to 1737 Post Street for Jay Naganuma for Maruwa Foods Company, will

1 serve the public convenience and necessity of the people of the City and County of San
2 Francisco.

3 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only
4 between the hours of 9:00 a.m. and 9:00 p.m. each day of the week; (2) The
5 petitioner(s) shall be responsible for maintaining free of litter the area in front of and
6 adjacent to the premises over which they have control.


