Resolution authorizing the San Francisco Department of Public Health (SFDPH) to enter retroactively into an agreement in the amount of \$84,328.13 with The Regents of the University of California San Francisco (UCSF), the primary contractor, to extend current child care health consultation services to family childcare providers, for the period of July 1, 2002 to June 30, 2003.

WHEREAS, UCSF is the recipient of a grant award from the State of California, California Children and Families Commission (CCFC) for the conduct of a program entitled "Child Care Health Linkages Project"; and,

WHEREAS. It is considered in the best interests of CCFC, UCSF, and SFDPH to participate in this project; and,

WHEREAS, UCSF has agreed to reimburse SFDPH in the amount of \$84,328.13 under the terms of this agreement; and,

WHEREAS, As a condition of receiving the funds UCSF requires SFDPH to enter into a subcontract (The "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 030023 , which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS. The contract budget includes provision for indirect costs of \$4,015.625; now, therefore, be it

RESOLVED, That SFDPH is hereby authorized to enter retroactively into a subcontract agreement in the amount of \$84,328.13 with UCSF, the primary contractor, for services under the "Child Care Health Linkages Project"; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate all positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.
