9 WHEREAS, Audrey Joseph is seeking transfer of a Type 48 on-sale general
10 public premises license for Night Gallery, located at 442 Jessie Street; and,

11 WHEREAS, The City Planning Department has verified that the area is properly
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
18 on-sale general public premises license from 177 Townsend Street to 422 Jessie Street
19 for Audrey Joseph for Night Gallery, will serve the public convenience and necessity of
20 the people of the City and County of San Francisco.

21 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only
22 between the hours of 10:00 a.m. to 2:00 a.m. Monday through Thursday; (2)
23 Entertainment provided shall not be audible beyond the area under control of the
24 licensee; (3) The sale of alcoholic beverages for consumption off the premises
25 prohibited; (4) The licensee shall regularly patrol the area under her control in an effort

1 to prevent the loitering of persons about the premises; (5) The petitioner(s) shall be
2 responsible for maintaining free of litter the area in front of and adjacent to the premises
3 over which they have control.




