**Resolution authorizing the Recreation and Park Department to accept and expend a grant in the total amount of \$200,000 from the California Department of Parks and Recreation under the Fiscal Year 2000 Park Bond Act: Regional Youth Soccer and Baseball Facilities for the renovation of the Soccer Field at Youngblood Coleman Recreation Center.**

WHEREAS, the Regional Youth Soccer and Baseball Facilities Program provides funding to rehabilitate existing neighborhood soccer and baseball facilities; and

WHEREAS, The California Department of Parks and Recreation has been delegated the responsibility for the administration of this grant project, setting up necessary procedures; and,

WHEREAS, in 2000, the California Department of Parks and Recreation offered the Regional Youth Soccer and Baseball Facilities Program grant of \$200,000 to the City and County of San Francisco for renovations of the soccer field at Youngblood Coleman Recreation Center; and

WHEREAS, The Recreation and Park Department will enter into an agreement with the California Department of Parks and Recreation for the subject project;


Now, therefore, be it

RESOLVED, That the City and County of San Francisco Board of Supervisors hereby:


1. Approves the acceptance and expenditure of \$200,000 for capital improvements to the soccer field at Youngblood Coleman Recreation Center;

- 9 for the completion of the aforementioned project.
- 10 5. Waives inclusion of indirect costs in the grant budget.




