20 universal respect and admiration of faculty, staff, administrators, students, and community

22 WHEREAS, Ms. Frances F. Lee has dedicated her career in community service and
23 social services having worked as a social worker and program director for nonprofit
24 organizations, such as the International Institute of San Francisco and the Chinese
25 Newcomers Service Center; and

1 WHEREAS, Ms. Frances F. Lee has been a consistent and devoted leader in the Asian
2 American community having served on the Board of Directors of Chinese for Affirmative
3 Action for the past 19 years and other various local boards throughout her career; now,




