3 **Resolution determining that the issuance of a Type 48 on-sale general public premises**
4 **liquor license to Patrick Gilles, Steve Bowman and Jay Seigan, for Red Devil Lounge**
5 **located at 1695 Polk Street (District 3), in exchange for its current Type 47 on-sale**
6 **general eating place license, will serve the public convenience and necessity of the**
7 **people of the City and County of San Francisco, in accordance with section 23958.4 of**
8 **the California Business and Professions Code, with conditions.**

10 WHEREAS, Patrick Gilles, Steve Bowman and Jay Seigan are seeking issuance of a
11 Type 48 on-sale general public premises liquor license for Red Devil Lounge, located at 1695
12 Polk Street (District 3), in exchange for its current Type 47 on-sale general eating place
13 license; and,

14 WHEREAS, The City Planning Department has verified that the area is properly zoned;
15 and recommends approval; and,

16 WHEREAS, The Police Department recommends that the liquor license application be
17 approved with conditions; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business and
19 Professions Code, the Board of Supervisors of the City and County of San Francisco hereby
20 determines for the foregoing reasons that the issuance of a Type 48 on-sale general public
21 premises liquor license, to Patrick Gilles, Steve Bowman and Jay Seigan for Red Devil
22 Lounge, located at 1695 Polk Street (District 3), in exchange for its current Type 47 on-sale
23 general eating place license, will serve the public convenience and necessity of the people of
24 the City and County of San Francisco.

1 Condition (1) Sales and service of alcoholic beverages shall be permitted only between
2 the hours of 4:00 p.m. and 2:00 a.m. each day of the week; (2) The petitioner(s) shall be
3 responsible for maintaining free of litter the area in front of and adjacent to the premises over
4 which they have control; (3) All doors shall kept closed at all time during the operation of the
5 premises except in cases of emergency and to permit deliveries. All doors not consist solely
6 of a screen or ventilated security door; (4) The sale of alcoholic beverages for consumption off
7 the premises is strictly prohibited; (5) The petitioner(s) shall police the area under their control
8 in an effort to prevent the loitering of persons about the premises; (6) Entertainment provided
9 shall not be audible beyond the area under control of the licensee; (7) The petitioner(s) shall
10 make a reasonable effort to keep delivery vehicles from blocking the sidewalk or double
11 parking on the street.




