Resolution authorizing the San Francisco Department of Public Health (SFDPH) to enter retroactively into an agreement in the amount of \$37,929 with The Regents of the University of California San Francisco (UCSF), the primary contractor to collaborate in developing, testing. evaluating, and refining an AIDS-related training package, for the period of July 1, 2002, to June 30, 2003.

WHEREAS, UCSF is the recipient of a grant award from the California Department of Health Services (CDHS) for the conduct of a program titled "Evaluating HIV Prevention in California"; and,

WHEREAS, It is considered in the best interests of CDHS, UCSF, and SFDPH to collaborate in this project; and,

WHEREAS, UCSF has agreed to reimburse SFDPH in the amount of \$37,929 under the terms of this agreement; and,

WHEREAS, As a condition of receiving the funds UCSF requires SFDPH to enter into a subcontract (The "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 030388 , which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The contract budget includes provision for indirect costs of \$4,064; now, therefore, be it

RESOLVED, That SFDPH is hereby authorized to enter retroactively into a subcontract agreement in the amount of \$37,929 with UCSF, the primary contractor, for AIDS-related training as defined under this Agreement, and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate all positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.
