

1 [Accept - Expend State Grant]

2 **Authorizing the Mayor's Office of Criminal Justice (MOCJ) to accept and expend funds**  
3 **in the amount of \$2,634,179 from the State Board of Corrections, from funds made**  
4 **available under Assembly Bill 1913 – known as the Schiff-Cardenas Crime Prevention**  
5 **Act of 2000 (CPA 2000), for programs and approaches that have been demonstrated to**  
6 **be effective in reducing delinquency.**

7 WHEREAS, MOCJ is the lead programmatic and fiscal agency of the county in  
8 administering CPA 2000, which provides funds for the county to implement a comprehensive  
9 multi-agency juvenile justice plan; and

10 WHEREAS, CPA 2000 requires that the county's local juvenile justice coordinating  
11 council, whose membership is described in Section 749.22 of the Welfare and Institutions  
12 Code, update its Juvenile Justice Local Action Plan and develop an annual expenditure plan  
13 for CPA 2000; and

14 WHEREAS, CPA 2000 also requires that the county Board of Supervisors, and in the  
15 case of a city and county the Mayor, approve the updated juvenile justice local action plan and  
16 the CPA 2000 expenditure plan; and

17 WHEREAS, the City originally established the Juvenile Justice Coordinating Council  
18 through resolution 170-97; and

19 WHEREAS, the Chief Probation Officer, Jesse Williams, as required by CPA 2000 and  
20 Section 749.22 of the Welfare and Institutions Code, serves as the chair of the Juvenile  
21 Justice Coordinating Council; and

22 WHEREAS, on March 27, 2003 the Juvenile Justice Coordinating Council, chaired by  
23 the Chief Probation Officer, met and recommended to the Board of Supervisors the updated  
24 local action plan and the expenditure plan for the 2003 allocation of the CPA 2000 grant; and

1           WHEREAS, all funds provided through CPA 2000 are for direct services to youth, it is  
2 requested that indirect costs be waived; therefore, be it

3           RESOLVED, that the City and County of San Francisco hereby authorizes MOCJ to  
4 accept and expend \$2,634,179 from the State Board of Corrections, under CPA 2000 for  
5 programs and approaches that have been demonstrated to be effective in reducing  
6 delinquency; and

7           BE IT FURTHER RESOLVED, all interest earned and prior year unexpended  
8 encumbered funds of this grant is appropriated to support approved 2003 CPA programs; and

9           BE IT FURTHER RESOLVED that the County assures that the Board of Supervisors  
10 has reviewed and approves the county's update to the Comprehensive Multi-agency Juvenile  
11 Justice Plan dated March 2003; and

12           BE IT FURTHER RESOLVED that the Director of the Mayor's Office of Criminal Justice  
13 is authorized to sign the application for approval submitted to the Board of Corrections; and

14           BE IT FURTHER RESOLVED that the City and County of San Francisco assures that it  
15 has adhered to the requirements of CPA 2000 and of the Board of Corrections regarding the  
16 submission of the plan; and


17           BE IT FURTHER RESOLVED that the plan has been developed and provided to the  
18 Board of Corrections in a format determined by the Board of Corrections regarding  
19 submission of the Plan; and


20           BE IT FURTHER RESOLVED that the City and County of San Francisco, upon  
21 approval from the Board of Corrections, will adhere to the requirements of the CPA 2000  
22 regarding the expenditure of CPA 2000 funds and the submission of required Board of  
23 Corrections reports.




