4 **Resolution accepting a gift of \$55,000 from the Market Street Railway and authorizing**
5 **said funds to be expended for the purchase of Historic Streetcar #162 from the Orange**
6 **Empire Railway Museum.**

8 WHEREAS, The Municipal Transportation Agency (MUNI), through its Director of
9 Transportation, recently approved a contract with the Orange Empire Railway Museum (OERM),
10 which contains an option to purchase Historic Streetcar #162 from OERM for \$70,000; and
11

12 WHEREAS, The Market Street Railway has pledged a total of \$55,000 to Muni toward
13 the purchase of Historic Streetcar #162; and,

14 WHEREAS, This Board, through Resolution No. 62-03, approved the sale of Car #96 to
15 the City of Issaquah, Washington, for \$15,000, with the proceeds to be used for the purchase,
16 repair or rehabilitation of other vintage streetcars at the discretion of the Director of
17 Transportation; and

18 WHEREAS, The Director of Transportation has determined that the \$15,000 be used to
19 acquire Historic Streetcar #162 from OERM; and,

20 WHEREAS, MUNI has determined that the F-Market-Embarcadero Vintage Streetcar line
21 will require additional vehicles in order to provide an adequate level of passenger service; and

23 WHEREAS, On April 1, 2003, Muni's Board of Directors passed Resolution No. 03-064,
24 which urged this Board to accept the gift of \$55,000 from the Market Street Railway; now,
25 therefore, be it

1 RESOLVED, That the Board of Supervisors hereby accepts the gift of \$55,000 from the
2 Market Street Railway, and authorizes the expenditure of said funds for the purchase of Historic
3 Streetcar #62 from OERM.


