3 **Resolution authorizing the Department of the San Francisco Public Utilities**  
4 **Commission to accept and expend a grant in the amount of \$1 million from the**  
5 **Proposition 13 account for the removal of Niles and Sunol dams.**

7 WHEREAS, California voters approved Proposition 13 which authorized the issuance  
8 of \$1.97 billion in general obligation bonds to support safe drinking water, water quality, flood  
9 protection and water reliability projects throughout the state; and

10 WHEREAS, Niles and Sunol dams, located in the Alameda Creek Watershed, were  
11 constructed during the mid- to late- 1800's to provide water to the residents of San Francisco,  
12 prior to the construction of the Hetch Hetchy Aqueduct system; and

13 WHEREAS, Both dams are known impediments to steelhead trout migration; and

14 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; and

15 WHEREAS, The removal of Niles and Sunol dams has been a longtime goal for the  
16 SFPUC and the Alameda Creek Fisheries Restoration Workgroup; now, therefore, be it

17 **RESOLVED**, That Board of Supervisors authorizes the General Manager of the San  
18 Francisco Public Utilities Commission to accept and expend a \$1 million grant from  
19 Proposition 13 for the removal of Niles and Sunol dams; and be it

20 **FURTHER RESOLVED**, That the Board of Supervisors hereby waives inclusion of  
21 indirect costs in the grant budget.


