5 RESOLVED, that, in accordance with the provisions of the California Vehicle
6 Code and the San Francisco Traffic Code, the following regulations governing the
7 parking of vehicles are hereby enacted or rescinded as designated below:

8 **TOW-AWAY, NO STOPPING, MONDAY-FRIDAY, 4:00 PM TO 6:00 PM**
9 **(SIX-MONTH TRIAL) - RESCIND**

10 Fell Street, south side, from Baker Street to Scott Street (Fell Street bike
lanes).

11 **TOW-AWAY, NO STOPPING, MONDAY-FRIDAY, 4:00 PM TO 7:00 PM**
12 **(SIX-MONTH TRIAL) - ESTABLISH**

13 Fell Street, south side, from Divisadero Street to 182 feet easterly
(Fell Street bike lanes).

14 **TOW-AWAY, LANE MUST TURN LEFT (SIX-MONTH TRIAL) - ESTABLISH**

15 Fell Street, at Scott Street (Fell Street bike lanes).

18 Review Class 1(c)(9) changes in the traffic
and parking regulations where such changes
do not establish a higher speed limit or result
19 in more than a negligible increase in the use of
the street.


