3 **Resolution designating certain intersections as "STOP" intersections.**

5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
6 following intersections are hereby designated as "STOP" intersections, and the
7 Department of Parking and Traffic is hereby authorized and directed to cause "STOP"
8 signs to be installed thereat as designated below:

9 **STOP SIGNS - ESTABLISH**

10 Alemany Boulevard at Justin Drive, stopping Justin Drive at Alemany Boulevard,
11 north intersection, making this T-intersection an all-way STOP;

12 15th and De Haro Streets, stopping De Haro Street, making this intersection an
13 all-way STOP; and

14 Eucalyptus Avenue, Junipero Serra Frontage Road and Ocean Avenue,

15 stopping Junipero Serra Frontage Road at Ocean Avenue; and

16 stopping Eucalyptus Avenue at Ocean Avenue, making this five-legged
17 intersection a three-way STOP.

18 Categorically exempt from Environmental
19 Review Class 1(c)(9) changes in the traffic and
20 parking regulations where such changes do not
21 establish a higher speed limit or result in more
22 than a negligible increase in the use of the
23 street.

Alemaný Boulevard at Justin Drive, stopping Justin Drive at Alemaný Boulevard, north intersection, making this T-intersection an all-way STOP; 15th and De Haro Streets, stopping De Haro Street, making this intersection an all-way STOP; and Eucalyptus Avenue, Junipero Serra Frontage Road and Ocean Avenue, stopping Junipero Serra Frontage Road at Ocean Avenue; and stopping Eucalyptus Avenue at Ocean Avenue, making this five-legged intersection a three-way STOP.
