10 WHEREAS, The improvement of pedestrian safety is a critical priority in San Francisco;
11 and,

12 WHEREAS, DPT and the UC Berkeley Traffic Safety Center have systematically
13 analyzed pedestrian safety problems and assessed innovative technologies and approaches
14 to improve pedestrian safety in Phase 1 of this federally funded study; and,

15 WHEREAS, the Federal Highway Administration (FHWA) has indicated interest in
16 funding Phase 2 implementation, providing about \$560,000 for physical improvements,
17 education/outreach, and program evaluation; and,

18 WHEREAS, the Phase 1 study (with option for Phase 2) was approved by the Board of
19 Supervisors on January 14, 2002 (Resolution No. 12-02, File No. 012188) and by the Parking
20 and Traffic Commission on October 2, 2001 in Resolution No. 164-01-PTC; and,

21 WHEREAS, the grant budget includes provision for indirect costs of about \$55,000;
22 now, therefore, be it


