3 **Resolution authorizing the Department of Public Health, Laguna Honda Hospital to**
4 **accept and use a gift of equipment – two electric vehicles in the amount of \$14,310 from**
5 **the McKesson Corporation for the general benefit of all residents at Laguna Honda**

8 WHEREAS, the Department of Public Health, Laguna Honda Hospital is a recipient of
9 two electric vehicles that will be used to provide tours of the campus to educate current
10 residents, family members, visitors, and the general public about the Laguna Honda Hospital
11 Replacement Project; and,

12 WHEREAS, the value of the gift was determined from the manufacturer's suggested
13 retail cost. (Total price: \$14,310). On going operating and maintenance cost e.g., electricity,
14 safety inspections and repairs are estimated at \$1,000 per each vehicle annually. The cost will
15 be covered by the LHH Plant Services facility-operating budget (HLH 449470, as sub-object
16 #081PA).; and,

17 WHEREAS, the Department of Public Health, Laguna Honda Hospital received approval
18 by the Health Commission to accept and use this gift valued to be \$14,310; and,
19 now, therefore, be it

20 RESOLVED, That the Department of Public Health, Laguna Honda Hospital is hereby
21 authorized to accept and use a gift estimated to be \$14,310 donated to Laguna Honda
22 Hospital from the McKesson Corporation to be used by the Hospital to transport residents,
23 family members, visitors, and the general public around the campus.


