3 **Resolution determining that the transfer of a Type 48 on-sale general public**
4 **premises license from 811 Valencia Street to 662 Mission Street (District 6), to**
5 **Shawman Group, LLC, dba as "Fluid", will serve the public convenience and**
6 **necessity of the people of the City and County of San Francisco, in accordance**
7 **with Section 23958.4 of the California Business and Professions Code. with**

10 WHEREAS, Shawman Group, LLC is seeking transfer of a Type 48 on-sale
11 general public premises license from 811 Valencia Street to 662 Mission Street for
12 Fluid; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and recommends approval, and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
20 on-sale general public premises license from 811 Valencia Street to 662 Mission Street
21 (District 6), to Shawman Group, LLC, dba as "Fluid", will serve the public convenience
22 and necessity of the people of the City and County of San Francisco.

23 Conditions: 1) The sale and service of alcoholic beverages shall be permitted
24 only between the hours of 10:00 a.m. and 2:00 a.m. each day of the week; 2) Petitioner
25 shall regularly police the area under their control in an effort to prevent the loitering of

1 persons about the premises; 3) The petitioner shall be responsible for maintaining free
2 of litter the area adjacent to the premises over which they have control; and shall
3 maintain a contract for steam cleaning services as long as they have the business; 4)
4 Entertainment provided shall not be audible beyond the area under control of the
5 licensee; 5) The sale of alcoholic beverages for consumption off the premises is strictly
6 prohibited.




