11 WHEREAS, Under Board of Supervisors’ authorization, the Airport Commission  
12 accepted and executed grant agreements on behalf of the City with the Federal Aviation  
13 Administration (“FAA”) for AIP Grants 16, 17 and 19; and

14 WHEREAS, To maximize the utilization of grant funds, the FAA has agreed to amend  
15 AIP 16 to include the reconstruction of Taxiway “C” and “Q”; and,

16 WHEREAS, The FAA has agreed to amend AIP 17 by reprogramming the mitigation  
17 planning and assessment portion of grant fund, in the amount of <sup>\$1,202,977</sup> ~~\$4,199,790-~~, to the existing  
18 airport development projects that were listed and approved under AIP 17, which includes  
19 construction of Taxiway “Z” bypass (phase II), acquisition of an ARFF vehicle, and installation  
20 of security improvements; and,

21 WHEREAS, The FAA has also agreed to amend AIP 19 to replace the grant fund  
22 previously authorized to conduct an environmental impact study for runway reconfiguration,  
23 with a North and West Field Drainage Improvement project; now, therefore, be it

24 **RESOLVED, That the Airport Commission, which has jurisdiction over the San**  
25 **Francisco International Airport, is hereby authorized to accept and execute the amendment**
