3 **Resolution appointing Stephen Griswold and Dhaya Lakshminarayanan, terms ending**
4 **April 5, 2005 to the Urban Forestry Council. Residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated persons to serve as members of the Urban
8 Forestry Council, pursuant to the provisions of the San Francisco Administrative Code,
9 Chapter 5, Article XXIII, for the term specified:

10 Stephen Griswold, (residency requirement waived) new appointment, seat 5, must be a
11 representative of the Golden Gate National Recreational Area, for a 2 year term ending April
12 5, 2005.

13 Dhaya Lakshminarayanan, succeeding Diana Cohen, resigned, seat 8, must be a
14 representative of the community for the unexpired portion of a two-year term ending April 5,
15 2005.

16 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 17 1. The membership of the Urban Forestry Council has a goal to be representative of
18 the diversity of the City and County of San Francisco.
- 19 2. Applicant Stephen Griswold, a new appointee, who is not a resident of San
20 Francisco, is a person with experience that uniquely qualifies him/her to serve on
21 the Urban Forestry Council.
- 22 3. The Urban Forestry Council has attempted to fill the position, for which Stephen
23 Griswold was nominated, with an individual who is a City resident and who has the
24 specific experience, skills, and qualifications, but has been unable to do so at this
25

time. The Rules Committee has certified that Stephen Griswold is qualified to serve on the Urban Forestry Council.

4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Urban Forestry Council at this time; and, be it

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for Stephen Griswold, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
