4 **Resolution urging 108th U.S. Congress to link National School Lunch Eligibility Criteria**
5 **to Regional Poverty Indicators and to increase the Program's Reimbursement Rate.**

6 WHEREAS, San Francisco is disproportionately affected by a higher cost of living than
7 most cities across the nation; and

8
9 WHEREAS, Higher expenses in San Francisco affect the ability of the San Francisco
10 Unified School District to adequately meet the nutritional needs of children, particularly those
11 who are low-income; and,

12 WHEREAS, While federal funding has kept up with the national cost of living, it has not
13 adequately provided for services in San Francisco due to regional variances in the cost of
14 food and supplies related to market availability and distribution costs, as well as differences in
15 the cost of labor; and,

17 WHEREAS, While federal funding has kept up with the national cost of living, it has not
18 adequately provided for services in San Francisco due to regional variances in the cost of

22 WHEREAS, numerous students in the San Francisco Unified School District are
23 deemed ineligible for the National School Lunch Program despite their real need because of
24 criteria that are not aligned with San Francisco's cost of living; now, therefore, be it

4 the National School Lunch Program based on regional and area costs and update it at regular
5 intervals."

8 urges the 108th U.S. Congress in the reauthorization of the Child Nutrition Act, to include
9 California on the list of states with higher reimbursement rates to reflect the differences
10 between the costs of providing meals and supplements in all other States, similar to the
11 higher reimbursement rates in effect for Alaska and Hawaii and for some schools with higher
12 percentages of low-income children; and, be it

15 of this resolution to San Francisco's State and Federal legislative delegation.




