RESOLUTION NO. 704-03

1 [Improve traffic and pedestrian safety in San Francisco through a community-based program  
2 to prevent driving under the influence (DUI) and resultant traffic injuries.]

3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **accept and expend retroactively a grant in the amount of \$439,455 from the California**  
5 **Business, Transportation & Housing Agency Office of Traffic Safety (CBTHAOTS) to**  
6 **prevent DUI and resultant traffic injuries and to enter into an agreement for the use of**  
7 **these funds; for the period of October 1, 2003 to December 31, 2005.**

9 WHEREAS, SFDPH has applied for and been awarded a grant from CBTHAOTS in the  
10 amount of \$439,455 to prevent DUI and resultant traffic injuries; and,

11 WHEREAS, As a condition of receiving the grant funds, CBTHAOTS requires the City  
12 to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the  
13 Board of Supervisors in File No. 031530, which is hereby declared to be a part of  
14 this resolution as if set forth fully herein; and,

15 WHEREAS, The grant budget includes provision for indirect costs of \$39,570; and,

16 WHEREAS, This Resolution requires expedited review by the Board of Supervisors  
17 because the grant agreement will not be available in final form until after the grant start date;  
18 and,

19 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds  
20 may be placed automatically on consent agendas in committee, as they are usually  
21 considered to be routine items, and this resolution authorizes the acceptance and expenditure  
22 of grant funding; now, therefore, be it


23 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a  
24 grant in the amount of \$439,455 from CBTHAOTS; and, be it

1 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
2 grant funds in accordance with the requirements set forth in the Agreement, pursuant to San  
3 Francisco Administrative Code section 10.170-1; and, be it




4 FURTHER RESOLVED, That the Director of Health is authorized to enter into the

6 FURTHER RESOLVED, That the Controller is directed to designate the positions  
7 created under the grant as "G" or grant-funded positions which would terminate when the  
8 agreement expires.
