3 **Resolution appointing Joe LaTorre, term ending December 22, 2003 to the Lead Hazard**
4 **Reduction Citizens Advisory Committee, residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated person to serve as a member of the Lead
8 Hazard Reduction Citizens Advisory Committee, pursuant to the provisions of the San
9 Francisco Health Code, Section 1608, for the term specified:

10 Joe LaTorre (residency requirement waived), succeeding Linda Salas, resigned, Seat
11 No. 6, must be a representative involved in housing and community development issues from
12 the Mayor's office, for the unexpired portion of a four-year term ending December 22, 2003;
13 and, be it

14 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 15 1. The membership of the Lead Hazard Reduction Citizens Advisory Committee has a
16 goal to be representative of the diversity of the City and County of San Francisco.
- 17 2. Applicant Joe LaTorre, a new appointee, who is not a resident of San Francisco, is
18 a person with experience that uniquely qualifies him/her to serve on the Lead
19 Hazard Reduction Citizens Advisory Committee.
- 20 3. The Lead Hazard Reduction Citizens Advisory Committee has attempted to fill the
21 position, for which Joe LaTorre was nominated, with an individual who is a City
22 resident and who has the specific experience, skills, and qualifications, but has
23 been unable to do so at this time. The Rules Committee has certified that Joe
24 LaTorre is qualified to serve on the Lead Hazard Reduction Citizens Advisory
25 Committee.

1 4. After exercising due diligence, the Board of Supervisors concludes that there is no
2 other possible representative, who is a resident of San Francisco and who has the
3 specific experience, skills, or qualifications possessed by this applicant, and who is
4 willing to serve on the Lead Hazard Reduction Citizens Advisory Committee at this
5 time; and, be it

6 FURTHER RESOLVED, That the Board of Supervisors waives the residency
7 requirement for Joe LaTorre, as allowed in cases where no qualified City resident, willing to
8 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
9 appointed to boards, commissions, and advisory bodies established by legislative act of the
10 Board of Supervisors to be resident(s) of the City and County of San Francisco.
