8 WHEREAS, the safety of the City and County of San Francisco requires emergency
9 services equipped and prepared to respond to potential terrorist attacks; and,

10 WHEREAS, The 2003 Omnibus Appropriations Act authorizes federal funding to State
11 and local governments for emergency equipment, exercises, and planning; and,

12 WHEREAS, The California Governor's Office of Emergency Services has been
13 delegated responsibility for the administration of these funds within California and grant funds
14 are available from the Governor's Office of Emergency Services for emergency equipment,
15 planning, and exercises; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$19,283; now,
17 therefore, be it

18 RESOLVED, That the Board of Supervisors hereby authorizes the Director of
19 Emergency Services to accept and expend a Homeland Security grant of up to \$771,317 from
20 the California Governor's Office of Emergency Services to fund emergency equipment,
21 planning, and exercises for the City and County of San Francisco; and be it

22 FURTHER RESOLVED, That the Director of Emergency Services is hereby authorized
23 and empowered to execute, deliver, and perform, in the name of the City and County of San
24 Francisco, all applications, contracts, agreements, amendments and payment requests






