3 **Resolution retroactively authorizing the Office of the District Attorney to retroactively**
4 **accept and expend a grant in the amount of \$155,000 from the California Office of**
5 **Criminal Justice Planning for the operation of the Elder Abuse Vertical Prosecution**
6 **Program.**

8 WHEREAS, The District Attorney's Office and the City and County of San Francisco
9 desire to continue a certain project designated the Elder Abuse Vertical Prosecution Program
10 with funds made available through the California Office of Criminal Justice Planning (OCJP);
11 and,

12 WHEREAS, All positions supported by these funds shall be coded "G" in the District
13 Attorney's budget; and,

14 WHEREAS, The District Attorney proposes to maximize use of available grant funds on
15 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

16 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
17 the grant budget; and be it

18 FURTHER RESOLVED, That the District Attorney of the City and County of San
19 Francisco is authorized on behalf of the City and County of San Francisco to retroactively
20 accept and expend funds from OCJP to continue the Elder Abuse Vertical Prosecution
21 Program; and be it

22 FURTHER RESOLVED, That in the event the OCJP consents to continue funding the
23 Elder Abuse Vertical Prosecution Program, the District Attorney of the City and County of San
24 Francisco is authorized to execute any amendments or augmentations of said program except

1 as any amendment or augmentation would increase any hard matching fund obligations of the
2 City and County of San Francisco pursuant to the contract; and be it

3 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
4 execute, deliver and perform, in the name of the City and County of San Francisco, all
5 applications, contracts, agreements, amendments and payment requests necessary for the
6 purpose of securing Elder Abuse Prosecution Program grant funds and to implement and
7 carry out the purposes specified in the applicable grant application; and be it

8 FURTHER RESOLVED, That the grant funds received hereunder shall not be used to
9 supplant local funds that would, in the absence of the Elder Abuse Vertical Prosecution
10 Program, be made available to support the prosecution of crimes against the elderly; and be it

11 FURTHER RESOLVED, That it is agreed that any liability arising out of the
12 performance of the Grant Award Agreement, including civil court actions for damages, shall
13 be the responsibility of the grant recipient and the authorizing agency.
