18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines that the transfer of a Type 20 off-sale beer and wine  
20 alcoholic beverage control license from 421 Haight Street to 350 California Street  
21 (District 3), to Mitra Ghiasi, dba San Francisco News & Gifts, will serve the public  
22 convenience and necessity of the people of the City and County of San Francisco.

23 Condition: The sale and service of alcoholic beverages shall be permitted only  
24 between the hours of 7:00 a.m. and 7:00 p.m. each day of the week.
