11 WHEREAS, The Excelsior Branch Library has been improved to provide complete
12 access, modern technologies, solar panels for energy efficiency, new furniture and displays,
13 updated books and materials collections, and more computers with access to the internet to
14 provide a learning environment of maximum efficiency; and,

15 WHEREAS, The renovation has been a team effort on the part of branch manager
16 Terry Gwiazdowski and her staff, Phillip Sowers and his team at the City's Bureau of
17 Architecture, San Francisco Public Library administrators and staff, Department of Public
18 Works Bureaus of Architecture, Construction Management & Engineering, Friends of the San
19 Francisco Public Library, CDX Builders, Library Commissioners, and members of the
20 Excelsior community who raised funds and helped design the branch to suit their
21 neighborhood's needs; and

22 WHEREAS, The renovation of the Excelsior Branch Library is vital to the economic
23 and cultural revitalization of Mission Street and the Excelsior neighborhood; now, therefore,
