3 **Resolution authorizing the Department of the District Attorney of the City and County**  
4 **of San Francisco to retroactively accept and expend a grant in the amount of \$443,989**  
5 **through the United States Department of Justice, Office of Juvenile Justice and**  
6 **Delinquency Prevention, entitled "Bayview Community Response Network."**

8 WHEREAS, The City and County of San Francisco is committed to combating gun and  
9 gang violence; and,

10 WHEREAS, The City and County of San Francisco desires to support the creation of a  
11 Community Response Network collaborative in Bayview Hunters Point and to support the  
12 existing Mission Community Response Network; and,

13 WHEREAS, District Attorney Kamala D. Harris and Congresswoman Nancy Pelosi  
14 have worked to secure federal funds for this purpose through the United States Office of  
15 Juvenile Justice and Delinquency Prevention (hereafter "OJJDP"); and,

16 WHEREAS, there is no match requirement for this grant; now, therefore, be it

17 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of  
18 the City and County of San Francisco to retroactively accept and expend funds from OJJDP to  
19 support a Bayview Community Response Network and the Mission Community Response  
20 Network; and be it

21 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
22 indirect costs in the grant budget; and be it

23 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of  
24 the City and County of San Francisco the necessary Grant Award Agreements for this project,  
25 including any extensions, augmentations or amendments thereof; and be it

1 FURTHER RESOLVED, That the District Attorney is authorized and empowered to  
2 execute, deliver and perform, in the name of the City and County of San Francisco, all  
3 applications, contracts, agreements, amendments and payment requests necessary for the  
4 purpose of securing these OJJDP grant funds and to implement and carry out the purposes  
5 specified in the applicable grant application; and be it

6 FURTHER RESOLVED, That two positions funded entirely through this grant will be  
7 added to the District Attorney's budget for FY2005-06, including 1.0 FTE 8135 Victim Witness  
8 Investigator III (Project Coordinator) and 1.0 FTE 8104 (Community Advocate); and be it

9 FURTHER RESOLVED, That a 0.6 FTE 2931, Marriage, Family and Child Counselor,  
10 funded through this grant will be added to the Department of Public Health's budget for FY  
11 2005-06; and be it

12 FURTHER RESOLVED, That all new positions authorized in this resolution shall be  
13 coded "G" grant positions; and be it

14 FURTHER RESOLVED, That grant funds received hereunder shall not be used to  
15 supplant expenditures controlled by this body.



