11 WHEREAS, the Department of Public Health, through Requests for Proposal
12 processes, has selected four contractors to provide long term locked mental health
13 services, pharmacy management services and needed fiscal intermediary services to
14 enable it to provide residential and outpatient mental health services to clients who need
15 them; and

17 WHEREAS, these contractors provide services to more than 27,360 clients in
18 need of residential and outpatient mental health services; and

19 WHEREAS, these contracts shall be for the terms and amounts as shown on
20 the attachment to this resolution; now, therefore; be it

1 RESOLVED, that the Board of Supervisors hereby retroactively authorizes the Director
2 of Public Health and the Office of Contract Administration, on behalf of the City and
3 County of San Francisco, to approve these five contracts between the City and County
4 of San Francisco and the contractors shown on the attached list as set forth in File No.
5 081217 for the period of October 1, 2008 through June 30, 2013.


