

1 [Accept and expend grant funds for children's dental disease prevention services.]

3 **Resolution authorizing the San Francisco Department of Public Health (SF DPH) to**  
4 **accept and expend retroactively a three-year grant from the California Department of**  
5 **Public Health (CA DPH), to fund the California Dental Disease Prevention Program**  
6 **(CCDDPP), for the period of July 1, 2007 through June 30, 2010; and authorizing SF**  
7 **DPH to execute all documents and subsequent amendments related to this contract.**

9 WHEREAS, The CA DPH awarded SF DPH funds through the CCDDPP, for the period  
10 of July 1, 2007 through June 30, 2010 first for a total of \$91,290 and in November 2008  
11 reduced the amount by ten percent for fiscal years 2008-09 and 2009-10 to \$85,204; and,

12 WHEREAS, These funds support children's dental disease prevention services; and,

13 WHEREAS, The first two years of this recurring grant were approved through the San  
14 Francisco Consolidated Budget and Annual Appropriation Ordinance (FY 2007-08 and FY  
15 2008-09) for the original annual amount of \$30,430; and,

16 WHEREAS, The State informed SF DPH of a mandatory 10 percent reduction in funds  
17 for FY 2008-09 and FY 2009-10, changing the annual amount for those years to \$27,387 and  
18 the total amount for the three years to \$85,204; and,

19 WHEREAS, As a condition of receiving the funds CA DPH requires DPH to enter into  
20 an agreement (the "Agreement"), with amendment, a copy of which is on file with the Clerk of  
21 the Board of Supervisors in File No. 090132, which is hereby declared to be a part of this  
22 resolution as if set forth fully within; and,

23 WHEREAS, The budget includes a provision for indirect costs of \$3,631; and,

24 WHEREAS, A request for retroactive approval is being sought because SF DPH did  
25 not have a resolution for the first two years of this grant due to a paperwork oversight; and,

1 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH  
2 for one existing position, Dental Aid (Job Class #2202), .15 FTE; now therefore, be it

3 RESOLVED, That DPH is hereby authorized to accept and expend retroactively a grant  
4 in the amount of \$85,204, and authorizing SF DPH to execute all documents and  
5 amendments related to this contract; and, be it


6 FURTHER RESOLVED, DPH is hereby authorized to retroactively accept and expend  
7 the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it


8 FURTHER RESOLVED, That the Director of Health is authorized to enter into the


