3 **Resolution approving the Seventh Amendment to the Agreement between the City**  
4 **and Office Depot (Contractor) for office supplies, increasing the contract's dollar**  
5 **amount to ~~\$20,035,000~~ \$19,345,441, pursuant to Charter Section 9.118(b).**

7 WHEREAS, The City entered into an agreement with Contractor, dated January 5,  
8 2005, for office supplies, with a dollar amount of \$9,999,999, and the agreement has  
9 been amended by the following amendments, which raised the agreement's dollar  
10 amount as indicated:

17 WHEREAS, The Board approved the third amendment via Resolution 450-07,  
18 approved by the Board on August 7, 2007 and signed by the Mayor on August 15, 2007;

20 WHEREAS, The Board approved the fifth amendment via Resolution 412-08,  
21 approved by the Board on October 7, 2008 and signed by the Mayor on October 15,  
22 2008; and

23 WHEREAS, The City and the Contractor estimate that the agreement's dollar  
24 amount will be reached in the near future; and

1           WHEREAS, San Francisco Charter Section 9.118(b) requires Board approval by  
2 resolution for amendments of \$500,000 or more to agreements that exceed \$10 million;

4           WHEREAS, The proposed seventh amendment is on file with the Clerk of the  
5 Board of Supervisors in File No. 090556, which is hereby declared to be a part of  
6 this resolution as if set forth fully herein; now, therefore, be it

7           RESOLVED, That the Board of Supervisors approves the seventh amendment to  
8 the agreement, increasing the dollar amount by ~~\$2 million~~ \$1,310,441, for a total of  
9 ~~\$20,035,000~~ \$19,345,441, and extending the performance period through November 30,  
10 2009.


