3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**
4 **and expend retroactively a grant in the amount of \$50,000 from the Commonwealth**
5 **Fund to support the Healthy San Francisco program evaluation; for the period of March**
6 **1, 2009 through February 28, 2010.**

8 WHEREAS, The Commonwealth Fund awarded DPH \$50,000 to support an evaluation
9 of the Healthy San Francisco program, for the period of March 1, 2009 through February 28,
10 2010; and

11 WHEREAS, Funds provided under this grant will be used to conduct an evaluation of
12 Healthy San Francisco, a universal health access program that provides comprehensive
13 health services to uninsured, adult San Francisco residents who are ineligible for public health
14 insurance; and,

15 WHEREAS, This project budget includes \$40,000 in contractual services to conduct
16 the program evaluation; and,

17 WHEREAS, An ASO amendment is not required because funds are not used for
18 staffing purposes; and,

19 WHEREAS, The budget includes a provision for indirect costs of \$5,000;

20 WHEREAS, This grant is one of several that DPH is combining in order to help fund the
21 cost of the Healthy San Francisco program evaluation; and,

22 WHEREAS, A request for retroactive approval is being sought because the agreement
23 was not executed until April 17, 2009 and the start date for the project is March 1, 2009; now
24 therefore, be it




