3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to**  
4 **retroactively accept and expend funds from the Foundation for AIDS Research (amfAR)**  
5 **in the amount of \$102,421 to support the HIV Epidemiology project entitled “Assessing**  
6 **internet users preferences for structural and network interventions;” for the period of**  
7 **January 1, 2009 through December 31, 2009.**

9 WHEREAS, DPH was awarded a grant from amfAR for \$102,421 to fund the  
10 “Assessing internet users preferences for structural and network interventions” project, for the  
11 period of January 1, 2009 through December 31, 2009; and,

12 WHEREAS, The grant includes \$86,625 in funds for a subcontract with the Stop AIDS  
13 Project; and,

14 WHEREAS, The grant does not require an ASO amendment and reimburses DPH for  
15 one existing position, a Senior Physician Specialist (Job Class #2232) at .05 FTE, for the  
16 period of January 1, 2009 through December 31, 2009; and,

17 WHEREAS, The grant budget includes a provision for indirect costs in the amount of  
18 \$2,436; now, therefore, be it

19 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant  
20 in the amount of \$102,421 from amfAR; and, be it

21 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
22 agreement on behalf of the City; and, be it

23 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
24 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,




