11 Gardener; and,

12 WHEREAS, Dan then joined the Department of Public Works in 1980 as a Tree
13 Topper working with Palm Trees and other tall trees in our City; and,

14 WHEREAS, In 1984 Dan became the first Urban Forester at DPW and helped craft
15 and implement the City's Tree Ordinance working closely with the Neighborhood Parks
16 Council; and,

17 WHEREAS, In 1993 Dan returned to Recreation and Parks as an Urban Forester and
18 then became Assistant Superintendent and then Superintendent working with then General
19 Manager Elizabeth Goldstein; and,

20 WHEREAS, In 2005 Dan returned to DPW as the Deputy Bureau Manager of the
21 Bureau of Street Use and Mapping addressing a wide range of issues affecting our cityscape,
22 including the pedestal newsrack program, utility undergrounding, sidewalk repairs and our
23 public toilet program, among others; and,




