

1 [Approval of Amendment to the Owner Controlled Insurance Program for the
2 Laguna Honda Hospital Replacement Program]

3 Resolution authorizing the Director of Public Works to execute amendment to the
4 Owner Controlled Insurance Program for the Laguna Honda Hospital Replacement
5 Program from \$9,915,928 to \$15,279,662.

6 WHEREAS, The Director of Public Works has entered into an agreement dated June
7 30, 2005 with Willis Insurance Services of California, Inc. for professional services to design,
8 market and administer the Guaranteed Owner-Controlled Program (GCIP) for the Laguna
9 Honda Hospital Replacement Program; and,

10 WHEREAS, Section 9.118(b) of the Charter requires that all agreements in excess of
11 ten million dollars or amendments to said agreements in excess of \$500,000 be approved by
12 the Board of Supervisors; and,

13 WHEREAS, the Director intends to increase the four-year program to a six-year
14 program under said agreement to extend the policies for workers' compensation, general
15 liability, excess liability, pollution liability and builders' risk; and


16 WHEREAS, the Director intends to increase the sum under said agreement to
17 \$15,279,662; now, therefore, be it

18 RESOLVED, That the Board of Supervisors does hereby authorize the Director of
19 Public Works to enter into an amendment to the June 30, 2005 agreement with Willis
20 Insurance Services of California, resulting in a contract amount not to exceed \$15,279,662.
