1 [Renew Revolving Fund Agreement with State]

3 **Resolution authorizing the Office of the District Attorney of the City and County of San**
4 **Francisco to renew its current agreement with the California Victim Compensation and**
5 **Government Claims Board, an agent of the State of California, for a revolving fund in**
6 **the amount of \$75,000 to be used to pay for verified funeral/burial expenses for eligible**
7 **homicide victims and emergency relocation for victims of domestic violence and**
8 **sexual assault for an additional two years from July 1, 2009 through June 30, 2011.**

10 WHEREAS, The District Attorney and the City and County of San Francisco desire to
11 renew the current agreement with the California Victim Compensation and Government
12 Claims Board in accordance with Government Section 13835 to provide a means to pay for
13 verified funeral/burial expenses for eligible homicide victims and emergency relocation for
14 victims of domestic violence and sexual assault, and be reimbursed by the State thereafter;
15 and

16 WHEREAS, This agreement would authorize the District Attorney's Victim Witness
17 Assistance Program to pay verified funeral/burial expenses for eligible homicide victims and
18 emergency relocation for victims of domestic violence and sexual assault out of the revolving
19 fund; and

20 WHEREAS, The fund maintains a process by which the District Attorney may make
21 speedy payments to service providers and increase service to victims; and

22 WHEREAS, Funds received hereunder shall not be used to supplant local funds that
23 would, in the absence of California Victim Compensation and Government Claims Board
24 Programs, be made available to support the assistance of victims of crime; and,

25 WHEREAS, The grant does not require an ASO amendment; and

1 WHEREAS, The District Attorney requests that indirect costs be waived, as they are
2 not allowed by granting agency; now, therefore, be it


3 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of
4 the City and County of San Francisco to execute on behalf of the City and County of San
5 Francisco a Revolving Fund Agreement with the California Victim Compensation and
6 Government Claims Board, including any extensions, augmentations or amendments thereof,
7 which shall include provisions to renew the revolving loan fund to be used to pay for verified
8 funeral/burial expenses and emergency relocation for victims of domestic violence and sexual
9 assault, extending it for an additional two years, from July 1, 2009 to June 30, 2011; and be it

10 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
11 indirect costs in the grant budget; and be it

12 FURTHER RESOLVED, That the District Attorney is authorized to sign and submit
13 claims to the California Victim Compensation and Government Claims Board for
14 reimbursement of funds expended for verified funeral/burial expenses for eligible homicide
15 victims and emergency relocation for victims of domestic violence and sexual assault, and be
16 it


17 FURTHER RESOLVED, That the State fund received hereunder shall not be used to
18 supplant local funds that would in the absence of the agreement, be made available to
19 support assistance to victims of crime.


