3 **Resolution designating Jewish Home of San Francisco as an Evaluation and Treatment**
4 **Facility for individuals 75 years and older; and authorizing the Director for Community**
5 **Behaviorial Health Services to enter into a Designation Agreement with said facility.**

7 WHEREAS, State law provides that the Board of Supervisors designate those facilities
8 that are authorized to involuntarily detain persons under the Lanterman-Petris-Short Act in
9 order to provide 72-hour evaluation and treatment services and 14-day intensive treatment
10 services (Welfare and Institutions Code Section 5404 and 9 California Code of Regulations
11 Sections 820 et. seq.); and

12 WHEREAS, These statutes require in addition that such facilities be approved by the
13 State Department of Mental Health; and

14 WHEREAS, The Board has designated various facilities through the adoption of
15 Resolutions, including Resolution No. 756-96; and

16 WHEREAS, There is an increasing need for psychiatric services for older adults in San
17 Francisco City and County; and

18 WHEREAS, The Department of Public Health recommends adding Hebrew Home for
19 Aged Disabled, a nonprofit public benefit corporation doing business as "The Jewish Home of
20 San Francisco" to the list of designated facilities with an exclusive focus on adults aged 75
21 years and older; and

22 WHEREAS, Designated facilities are required to operate in compliance with the
23 requirements, and subject to the terms and conditions, of the designation agreement
24 contained in Board of Supervisor's file number 090940, including any amendments which the

2 be a part of this Resolution as if set forth fully herein; now, therefore, be it

3 RESOLVED, That the Board hereby designates The Jewish Home of San Francisco to
4 involuntarily detain psychiatric patients aged 75 years and older for evaluation and treatment
5 as authorized by the Lanterman-Petris-Short Act; and be it

6 FURTHER RESOLVED, That the Board hereby authorizes the Director for Community
7 Behavioral Health Services to enter into a designation agreement with said facility.
