

1 [Resolution of Local Support for Proposition 1B Local Streets and Road Projects]

3 **Resolution authorizing local support for street resurfacing projects to be funded by FY**
4 **2009-10 Proposition 1B State Infrastructure Bond funds from the Local Street and**
5 **Road, Congestion Relief, and Traffic Safety Account of 2006.**

7 WHEREAS, On November 7, 2006, California voters approved Proposition 1B, the
8 Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006 (Prop 1B);
9 and,

10 WHEREAS, The Act apportioned \$2 billion for the Local Street and Road, Congestion
11 Relief, and Traffic Safety Account of 2006 to fund improvements to local transportation
12 facilities including repair and rehabilitation of local streets and roads; and,

13 WHEREAS, San Francisco's shares of Prop 1B LSR funds were programmed to the
14 Department of Public Works' street resurfacing program through the FY 2008-17 Citywide
15 Capital Plan approved by the Board of Supervisors under Resolution 145-07; and,

16 WHEREAS, In FY 2007-08 and FY 2008-09, the State allocated \$1.3 billion in Prop 1B
17 LSR funds to cities and counties, and between these two fiscal years the San Francisco
18 received a total of \$33 million to implement street resurfacing projects at various locations;
19 and,

20 WHEREAS, In FY 2009-10, AB 3X10 the State budget bill, appropriated the remaining
21 \$700 million of Prop 1B LSR funds to cities and counties and of this amount, San Francisco
22 will receive approximately \$6.4 million; and,

23 WHEREAS, The Board of Supervisors appropriated \$2.2 million of FY 2009-10 Prop
24 1B LSR funds in the FY 2009-10 Annual Appropriation Ordinance No. 184-09, and \$4.2

1 million is proposed to be appropriated to the Department of Public Works in the FY 2011-20
2 Citywide Capital Plan and the FY 2010-11 Annual Appropriation Ordinance No. _____; and,

3 WHEREAS, The Department of Public Works will use \$2.2 million of the \$6.4 million for
4 projects in the FY 2009-10 street resurfacing work plan and will use the remaining \$4.2 million
5 for projects in the FY 2010-11 street resurfacing work plan; and,

6 WHEREAS, Each city and county must submit to the State Department of Finance a
7 list of projects expected to be funded with bond funds before an allocation is made; and,

8 WHEREAS, The adopted project list does not limit the flexibility of the local agency to
9 make substitutions in response to local priorities; and,

10 WHEREAS, The Department of Public Works plans to fund the following list of projects
11 with Prop 1B LSR funds:

12 Winfield Street from Eugenia Avenue to Cortland Avenue;

13 Plymouth Avenue from Sadowa Street to Ocean Avenue;


14 Howard Street from Steuart to 4th Street / 4th Street from Bryant to King Street; and

15 Various Locations Bureau of Street and Sewer Repair; and,

16 WHEREAS, The estimated useful life of the proposed repair is between 14 and 21
17 years; now, therefore be it

18 RESOLVED, That the Board of Supervisors approves the list of projects expected to be
19 funded with 2009-10 Prop 1B LSR bond funds.




