3 **Resolution determining that the transfer of a Type 20 Off-Sale Beer and Wine**
4 **Liquor License from 880 Harrison Street to 690 Stanyan Street (District 5) to**
5 **Joseph N. Rogoff for Whole Foods Market California Inc., dba Whole Foods**
6 **Market will serve the public convenience or necessity of the people of the City**
7 **and County of San Francisco, in accordance with Section 23958.4 of the**
8 **California Business and Professions Code, with conditions.**

10 WHEREAS, Joseph N. Rogoff is seeking transfer of a Type 20 Off-Sale Beer and
11 Wine Liquor License for Whole Foods Market California Inc., dba Whole Foods Market,
12 located at 690 Stanyan Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned, with conditions; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20
20 Off-Sale Beer and Wine Liquor License from 880 Harrison Street to 690 Stanyan Street
21 for Joseph N. Rogoff for Whole Foods Market California Inc., dba Whole Foods Market,
22 will serve the public convenience or necessity of the people of the City and County of
23 San Francisco.

24 Planning Department Conditions: Alcohol Beverage Control license is permitted
25 in conjunction with the proposed grocery store use per conditional use authorization

1 under Case No. 2009.1103C (Motion No. 18024) and subject to Sections 790.55(a), (b),
2 and (c).

3 Police Department Conditions: 1) Sale, service, and consumption of alcoholic
4 beverages shall be permitted only between the hours of 8:00 a.m. and 10:00 p.m. each
5 day of the week; 2) The petitioners shall be responsible for maintaining free of litter the
6 area adjacent to the premises over which they have control; 3) The exterior of the
7 premises shall be equipped with lighting of sufficient power to illuminate and make
8 easily discernible the appearance and conduct of all persons on or about the premises.
9 Additionally, the position of such lighting shall not disturb the normal privacy and use of
10 any neighboring residences; 4) Graffiti shall be removed from the premises and all
11 parking lots under the control of the licensee within 72 hours of application. If the graffiti
12 occurs on a Friday or weekend day, or on a holiday, the licensee shall remove the
13 graffiti within 72 hours following the beginning of the next weekday.




