

1 [Accept and Expend Grant - Implementation of Programs for the Prevention, Care, and  
2 Treatment of HIV/AIDS - \$13,001]

4 **Resolution authorizing the Department of Public Health to retroactively accept and**  
5 **expend a grant in the amount of \$13,001 from the University of California San**  
6 **Francisco to participate in a program entitled “Implementation of Programs for the**  
7 **Prevention, Care, and Treatment of HIV/AIDS” for the period of July 1, 2010, through**  
8 **June 30, 2011.**

10 WHEREAS, University of California San Francisco (UCSF) is the recipient of a grant  
11 award from the Centers for Disease Control and Prevention supporting the Implementation of  
12 Programs for the Prevention, Care, and Treatment of HIV/AIDS; and,

13 WHEREAS, With a portion of these funds, UCSF has subcontracted with DPH in the  
14 amount of \$13,001 for the period of July 1, 2010 through June 30, 2011; and,

15 WHEREAS, As a condition of receiving the grant funds, UCSF requires the City to  
16 enter into an agreement (the “Agreement”), a copy of which is on file with the Clerk of the  
17 Board of Supervisors in File No.110126 ; which is hereby declared to be a part of this  
18 resolution as if set forth fully herein; and,

19 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH  
20 for one existing position, one Senior Physician Specialist (Job Class 2232) at .05 FTE, for the  
21 period of July 1, 2010 through June 30, 2011; and,

22 WHEREAS, A request for retroactive approval is being sought because DPH did not  
23 receive notification of the contract until December 14, 2010 for a project start date of July 1,  
24 2010; and,

1 WHEREAS, The budget includes a provision for indirect costs in the amount of \$1,393;  
2 now, therefore, be it

3 RESOLVED, That DPH is hereby authorized to accept and expend a grant retroactively  
4 in the amount of \$13,001 from UCSF; and, be it

5 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
6 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,  
7 be it

8 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
9 agreement on behalf of the City.


