Conditions: (1) Petitioners shall not permit their patrons or the general public to litter or congregate on the sidewalks adjacent to the licensed premises. (2) The petitioners shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control. (3) No noise shall be audible beyond the area under control of the licensees. (4) There shall be no live entertainment of any type permitted on the premises. (5) Sales and service of alcoholic beverages shall be permitted only between the hours of 10:00 a.m. to 10:00 p.m. each day of the week. (6) Individual servings shall not exceed six-ounce pours of beer or four-ounce pours of wine.
