4 **Resolution authorizing the Department of Public Health to retroactively accept and**
5 **expend a grant from the University of California San Francisco in the amount of**
6 **\$27,189 to participate in a program entitled "Atlanta HQ UCSF Technical Assistance to**
7 **Support President's Emergency Plan for AID;" for the period of April 1, 2011, through**
8 **March 31, 2012.**

10 WHEREAS, UCSF is the recipient of a grant award from the Centers for Disease
11 Control (CDC) supporting the Atlanta HQ UCSF Technical Assistance to Support President's
12 Emergency Plan for AID; and

13 WHEREAS, With a portion of these funds, UCSF has subcontracted with DPH in the
14 amount of \$62,123 for the period of April 1, 2011 through March 31, 2012; and,

15 WHEREAS, As a condition of receiving the grant funds, UCSF requires the City to
16 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
17 Board of Supervisors in File No.111043; which is hereby declared to be a part of this
18 resolution as if set forth fully herein; and

19 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
20 for one existing position, one Senior Physician Specialist (Job Class 2232) at .10 FTE, for the
21 period of April 1, 2011 through March 31, 2012; and

22 WHEREAS, A request for retroactive approval is being sought because DPH did not
23 receive notification of the subaward until July 27, 2011 for a project start date of April 1, 2011;


FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City.


