Resolution supporting California Senate Bill 1172, which bans sexual orientation change efforts for minors in the State of California.

WHEREAS, Senate Bill 1172, which would ban children under the age of eighteen from undergoing sexual orientation change efforts, is currently pending in the California State Assembly; and

WHEREAS, An individual's sexual orientation is not a disease, disorder, or illness; and WHEREAS, There is no evidence that any type of psychotherapy can change a person's sexual orientation; and

WHEREAS, Such practices of sexual orientation change efforts pose detrimental mental health risks to gay, lesbian and bisexual people including depression, guilt, hopelessness, shame, suicidal ideation and substance abuse, among other forms of psychological and emotional distress; and

WHEREAS, Minors who experience rejection by their family based on their sexual orientation face a variety of critical health issues, including depression, illegal drug use, and suicide attempts; and

WHEREAS, The American Psychiatric Association, the American Psychological
 Association, the American Counseling Association, the American Association of Marriage and
 Family Therapists, the National Association of Social Workers, and the American Academy of
 Pediatrics oppose efforts to change the sexual orientation of any individual; and

WHEREAS, SB 1172 prohibits therapists from engaging in harmful practices that seek
to change a minor's sexual orientation or the expression of the young person's sexual
orientation; and

1	WHEREAS, the City and County of San Francisco is home to a large and diverse
2	LGBT community, including many LGBT people who have come to San Francisco as a refuge
3	from discrimination and oppress, San Francisco being unwaivering in its commitment to
4	provide a safe and respectful environment for individuals from all walks of life; now, therefore,
5	be it
6	RESOLVED, that the City and County of San Francisco hereby supports California SB
7	1172.
