

1 [Accept In-Kind Gift - James R. Herman Cruise Terminal - Art Installation - \$250,000]

3 **Resolution authorizing the Port of San Francisco to accept a gift of art referred to as**  
4 **the James R. Herman Tribute valued at \$250,000 from the James R. Herman Memorial**  
5 **Committee for display at the new James R. Herman Cruise Terminal at Pier 27.**

7 WHEREAS, California Statutes of 1968, Chapter 1333 (the "Burton Act") and the San  
8 Francisco Charter, Section 4.114 and B3.581, empower the Port Commission ("Port  
9 Commission") with the power and duty to use, conduct, operate, maintain, manage, regulate  
10 and control the lands within Port Commission jurisdiction; and

11 WHEREAS, In 1998 the Port Commission adopted a resolution to name any future  
12 cruise terminal on Port property after Port Commissioner James R. Herman, a Port  
13 Commissioner from 1982 to 1998 and Port Commission President in 1990 and 1991; and

14 WHEREAS, The James R. Herman Memorial Committee (Committee) proposes to  
15 unconditionally give the Port an art piece, known as the James R. Herman Tribute (Tribute)  
16 created by the Floating Point Collective (Artist), intended for placement within the James R.  
17 Herman Cruise Terminal (Cruise Terminal) that recognizes James R. Herman's contributions  
18 and work on labor issues within San Francisco and while a member of the Port Commission;  
19 and

20 WHEREAS, The Tribute (including the cost of installation and replacement parts for a  
21 20 year period) has an estimated value of \$250,000; and

22 WHEREAS, The Port Commission is honored to receive the Committee's offer of the  
23 gift and has authorized the Executive Director to seek Board of Supervisor's approval of the  
24 gift (Port Commission Resolution 14-39); now, therefore, be it

1 RESOLVED, The Board of Supervisors authorizes the Port Commission to accept the  
2 gift of the Tribute on terms agreed by the Port, Committee and the Artist and to accept  
3 additional gifts of in-kind services and/or funding for maintenance of the Tribute maintenance  
4 if offered.
