3 **Resolution retroactively authorizing the Office of the District Attorney to accept and**
4 **expend a grant in the amount of \$290,704 from the California Office of Traffic Safety for**
5 **the Alcohol and Drug Impaired Driver Vertical Prosecution Program for the grant period**
6 **October 1, 2015 through September 30, 2016.**

8 WHEREAS, The San Francisco District Attorney's Office (SFDA) applied for funding
9 from the California Office of Traffic Safety for the Alcohol and Drug Impaired Driver Vertical
10 Prosecution Program and was awarded Two Hundred Ninety Thousand and Seven Hundred
11 Four dollars (\$290,704); and

12 WHEREAS, The purpose of the grant is to screen, investigate, and prosecute cases
13 involving motorists operating a vehicle while under the influence of drugs and alcohol; and

14 WHEREAS, The grant does not require an Annual Salary Ordinance (ASO)
15 Amendment; and


16 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
17 therefore, be it

18 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
19 the grant budget; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Office of
21 the District Attorney to retroactively accept and expend, on behalf of the City and County of
22 San Francisco, a grant from the California Office of Traffic Safety for the Alcohol and Drug
23 Impaired Driver Vertical Prosecution Program in the amount of \$290,704 to prosecute alcohol
24 and drug impaired driving cases.




