3 **Resolution determining that the transfer of a Type 21 off-sale general license from**  
4 **246-B 2nd Street to 282-2nd Street (District 6), to Oussama Mannaa, for Soma**  
5 **Wines and Spirits, Inc., dba Soma Wines and Spirits, will serve the public**  
6 **convenience or necessity of the City and County of San Francisco, in accordance**  
7 **with California Business and Professions Code, Section 23958.4, and**  
8 **recommending that the California Department of Alcoholic Beverage Control**  
9 **impose conditions on the issuance of the license.**

11 WHEREAS, Oussama Mannaa is seeking the transfer of a Type 21 off-sale  
12 general license from 246-B 2nd Street to 282-2nd Street Soma Wines and Spirits, Inc.,  
13 dba Soma Wines and Spirits; and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero (0) protests with the  
17 Department of Alcoholic Beverage Control under California Business and Professions  
18 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
19 Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) Sales of alcoholic beverages shall be permitted between the hours of 8:00  
22 a.m. and 12:00 a.m. midnight daily; 2) the sale, service and consumption of powdered  
23 alcohol or like non-liquid alcoholic beverage based product is prohibited; 3) loitering  
24 (defined as "to stand idly about; linger aimlessly without lawful business") is prohibited  
25 on any sidewalks or property adjacent to the licensed premises under the control of the

1 licensee as depicted on the ABC-257; and 4) deliveries to the licensed premises shall  
2 be permitted only between the hours of 7:00 a.m. and 6:00 p.m.; now, therefore, be it

3           RESOLVED, That in accordance with California Business and Professions Code,  
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
5 hereby determines for the foregoing reasons that the transfer of a Type 21 off-sale  
6 general license from 246-B 2nd Street to 282-2nd Street to Oussama Mannaa, for  
7 Soma Wines and Spirits, Inc., dba Soma Wines and Spirits, will serve the public  
8 convenience or necessity of the City and County of San Francisco; and, be it

9           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
10 San Francisco hereby endorses and adopts the recommendations of the Police  
11 Department listed above and recommends that the Department of Alcoholic Beverage  
12 Control issue the license with those conditions.
