

1 [Donation of Retired Fire Engine to City College of San Francisco]

3 **Resolution authorizing Fire Department to donate a retired fire engine to the City**  
4 **College of San Francisco Fire Academy Program.**

6 WHEREAS, City College of San Francisco (CCSF) is a leading educational institution  
7 for its Fire Academy Program and teaches those who wish to be future firefighters; and

8 WHEREAS, A large part of firefighting training focuses on manipulative skills and  
9 simulated drills with the aid of genuine equipment; and

10 WHEREAS, Firefighting equipment is expensive and difficult to obtain; and

11 WHEREAS, The Fire Department has recently taken receipt of ten new fire engines,  
12 allowing the Department to replace a number of old units that were no longer of operational  
13 use to the Department; and

14 WHEREAS, The San Francisco Fire Department wishes to donate a retired vehicle for  
15 educational training purposes; and

16 WHEREAS, Vehicle 145-585, a 1988 Mack Pumper, has been retired from service  
17 even as a relief piece; and

18 WHEREAS, Vehicle 145-585 would serve as a valuable training tool for pump training  
19 and hose evolutions, and the City College Fire Academy would benefit greatly from this  
20 vehicle as a training aid; and

21 WHEREAS, On March 26, 2015, the Fire Commission adopted Resolution No.  
22 2015-03, recommending that the Board of Supervisors approve the donation of a retired  
23 engine to City College of San Francisco; and

1           WHEREAS, The Fire Commission Resolution is on file with the Clerk of the Board of  
2 Supervisors in File No. 150937, which is hereby declared to be a part of this resolution as if  
3 set forth fully herein; and


4           WHEREAS, Municipal Code, Chapter 21, allows for commodities that have been  
5 declared as surplus to be disposed of in a manner that will best serve the interests of the City  
6 and will maximize the City's economic return on the surplus commodities by donating to public  
7 entities, non-profit organizations and schools; and

8           WHEREAS, Among the first criteria on the priority list for donation of surplus  
9 commodities are schools that are physically located in San Francisco; and

10           WHEREAS, City College of San Francisco is an institution of learning (school) and is  
11 physically located in San Francisco; now, therefore, be it

12           RESOLVED, That the San Francisco Fire Department is authorized to donate vehicle  
13 145-585 to the City College of San Francisco's Fire Academy Program.




