3 **Resolution determining that the issuance of a Type 64 general theatre license to**  
4 **Gray Area Foundation for the Arts, dba Gray Area, located at 2665 Mission Street**  
5 **(District 9), will serve the public convenience or necessity of City and County of**  
6 **San Francisco in accordance with California Business and Professions Code,**  
7 **Section 23958.4, and recommending that the California Department of Alcoholic**  
8 **Beverage Control impose conditions on the issuance of the license.**

10 WHEREAS, The Gray Area Foundation for the Arts is seeking the issuance of a  
11 Type 64 general theatre license for Gray Area Foundation for the Arts, dba Gray Area  
12 located at 2665 Mission Street (District 9); and

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed zero (0) protests with the  
16 Department of Alcoholic Beverage Control under California Business and Professions  
17 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
18 Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the  
20 following: 1) the sale of alcoholic beverages for consumption off the premises is strictly  
21 prohibited; 2) alcoholic beverages shall be served in containers clearly distinguishable  
22 from non-alcoholic beverage containers; 3) the sale of alcoholic beverages shall be  
23 limited to no more than two beverages per person per sale; 4) sales, services, and  
24 consumption of alcoholic beverages shall be exclusive to the first floor only; and 5) an  
25 employee or security guard shall be assigned the responsibility of ensuring all alcoholic

1 beverages remain inside the permitted area whenever the privileges of the ABC license  
2 are being exercised; now, therefore, be it

3       RESOLVED, That in accordance with California Business and Professions Code,  
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
5 hereby determines that the issuance of a Type 64 general theatre license to 2665  
6 Mission Street (District 9), to the Gray Area Foundation for the Arts for The Grand  
7 Theater, dba Gray Area, will serve the public convenience or necessity of the City and  
8 County of San Francisco; and, be it

9       FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
10 San Francisco hereby endorses and adopts the recommendations of the Police  
11 Department listed above and recommends that the Department of Alcoholic Beverage  
12 Control issue the license with those conditions.


