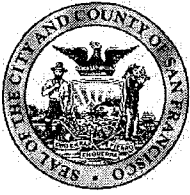

10 WHEREAS, The Airport Commission requested for bids for the Domestic Terminals 1  
11 and 3 Automated Teller Machines (ATM) Lease and Bank of America, N.A., was the sole  
12 responsive and responsible bidder; and

13 WHEREAS, The Airport Commission adopted Resolution No. 16-0070 on March 1,  
14 2016, awarding the Domestic Terminals 1 and 3 Automated Teller Machines (ATM) Lease to  
15 Bank of America, N.A.; now, therefore, be it

16 RESOLVED, That the Board of Supervisors hereby approves the Domestic Terminals 1  
17 and 3 Automated Teller Machines (ATM) Lease, copies of which are contained in Clerk of the  
18 Board of Supervisors' File No. 160295, for a five-year term with one two-year option to extend,  
19 exercisable at the sole discretion of the Airport Commission, and with a Minimum Annual  
20 Guarantee of \$365,000.00 for the first year of the lease; and, be it

21 FURTHER RESOLVED, That within thirty days of the lease being fully executed by all  
22 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
23 inclusion into the official file.




